Industry Context

About the ACA

- ACA QLDNT represents close to 145 Queensland & NT architectural businesses employing 1,300+ staff, from sole operators to national firms.
- We provide policy input, industrial relations representation, and business resources for architectural businesses.
- We partner closely with other industry representative organisations and agencies including Australian Institute of Architects, Consult Australia, the Office of the Queensland Government Architect and the Board of Architects of Queensland.

The Productivity Challenge in Plain Language

- o Flat for 20 years: construction output per worker has not grown since the early 2000s.
- Big pipeline: 1 million new homes by 2044 + Olympic infrastructure = unprecedented demand.
- Cost blow-outs: material prices *35 % post-COVID; labour shortages push wages up; contractor insolvencies rising.
- Design squeeze: tender timeframes shrinking; fees discounted below sustainable levels; rushed documentation → cost overruns on site.
- Bottom line: Queensland cannot build faster or cheaper unless systems (procurement, contracts, skills, tech, regulation) improve.

How Procurement Drives (or Destroys) Productivity

Current Issue	Impact	Solution
2-week tender windows for architectural engagements & "Christmas Eve" releases	Staff work overtime, cut quality, or abstain, supports wellbeing in business	Set minimum 4-week tender periods and a December–January blackout
30+ bidders for mid-size jobs	Industry wastes \$millions on losing bids	Use two-stage - EOI → shortlist 3 rule
Lowest-fee wins	Under-resourced design, more variations later	Weight quality ≥ 70 % in evaluation
Bespoke contracts with unlimited liability	Fewer bidders, higher premiums, defensive practice	Adopt un-amended AS 4122 ; cap liability at 2× fee



Detailed Recommendations (Numbered for Action)

1. Procurement

- a. Amend QPP to require two-stage EOI/shortlist for design tenders.
- b. Publish a Professional Services Fee Guidance note annually.
- c. Ensure architects are involved in developing design and technical briefs for all major projects.

2. Contracts & Risk

- a. Mandate un-amended AS 4122 and cap consultant liability on state projects.
- Establish a standing Contracts Advisory Panel by Q4 2025.
- Offer Government Professional Liability backstop for cladding/high-risk façades until the commercial market stabilises.
- d. Mandate Alternative Dispute Resolution (ADR) first mediation before litigation.

3. Workforce & Skills

- a. Fund 200 architectural cadetships over 3 years.
- b. Provide \$5m per year for Construction Digital Skills grants.
- c. Tie state contracts > \$5m to a wellbeing charter and certified CPD plans.
- d. Develop diversity targets scholarships for women, First Nations and regional students.

4. Technology & Innovation

- a. Launch a \$20m "Construction AI Challenge" fund.
- Require IFC-BIM deliverables on new state projects from 1 January 2027.
- c. Partner with CSIRO to create an open construction data platform.
- d. Provide \$25k SME tech vouchers for small firms to adopt AI/BIM tools.

5. Regulatory Reform

- a. Implement one-stop digital planning lodgement with statutory decision times.
- b. Maintain building code standards but provide 12-month transition windows.
- c. Fast-track mutual recognition for skilled interstate/overseas professionals.
- d. Fund QBCC random audits and create public register of non-conforming products.

6. Safety & Quality

- a. Legislate Principal Architect sign-off for Class 2-9 buildings > 4 storeys.
- b. Fund 20 independent Clerks-of-Works through a QBCC register.
- c. Enforce mandatory building manuals and digital handover on completion.
- d. **Mandate non-combustible façades** on Class 2 buildings > 3 storeys. Doing it right once is cheaper than re-cladding 400 buildings.

The above are specific, actionable recommendations that the government can implement in partnership industry to directly to address productivity, improve outcomes and enhance safety.



Conclusion

Productivity gains will come from **better systems**, **not harder labour**. By adopting the reforms outlined, Queensland can:

- Deliver projects faster and better value without sacrificing quality.
- o Strengthen the professional capability of the entire supply chain.
- o Protect the public through robust safety and risk governance.
- o Position Queensland as a national leader in construction innovation.
